This STALLION BREEDING CONTRACT for the breeding season of _____, is made and entered into on this _____ day of _____, _____, by and between _____, hereinafter designated Mare Owner. Mare Owner agrees to breed the mare _____, Reg. No. _____, to the stallion **Jack Silver Dust**, Reg. No. _____ for the fee of \$ **600.00**, for a live foal, subject to the following conditions:

1. The stallion fee includes a non-refundable booking fee of \$ **100.00**, payable upon execution of this contract. The balance of this fee must be paid, with all other expenses, when mare is picked up or when Mare Owner is invoiced, whichever is first. Invoices are payable upon receipt. Mare Owner may not remove mare from Breeders possession until all expenses are paid in full.
2. Breeder agrees to provide suitable facilities for the care and feed of mare and/or foal while in his/her custody. Mare Owner agrees to pay for care and feed at \$ **5.00** per day if mare owner supplies hay and grain or \$ **10.00** per day with mare owner not supplying hay and grain.
3. Breeder will exercise judgment consistent with recognized standards in care and supervision of mare and/or foal. Breeder assumes responsibility for arranging veterinarian and farrier services as necessary. Breeder's veterinarian will examine mare for normal breeding conditions and administer medical care as deemed for the health and safety of the mare and/or foal. All veterinarian and farrier expenses will be paid by Mare Owner.
4. Mares that are not halter broken will not be accepted
5. The mare shall be in a healthy and sound breeding condition, free from infections, contagious, and transmissible diseases. A current negative Coggins test, Photostat copy of registration papers (both sides), veterinarian's health certificate, plus a health, worming and immunization record must accompany mare; if not, Breeder's veterinarian will examine and/or test mare at Mare Owner's expense. Breeder reserves the right to refuse mare if not in satisfactory condition. If mare is refused, the booking fee shall constitute liquidated damages
6. Mare Owner agrees to pay \$ _____ to have mare foal on Breeder's premises. All veterinarian expenses incurred in connection with the foaling shall be paid by Mare Owner.
7. Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, Mare Owner will hold Breeder blameless. Mare Owner agrees to give Breeder ample opportunity to settle mare.
8. This Contract contains a Live Foal Guarantee. A live foal is described as a newborn foal which stands and nurses without assistance. If foal is born dead, there are return privileges for the current breeding season only if Breeder is notified within **10** days and receives a veterinarian's statement confirming death. If after being pronounced safe in foal, the mare should miscarry, abort or prove barren after leaving the Breeder's premises, Mare Owner has the privilege to return her for breeding during the current breeding season through _____, or the following year. _____
9. A Breeder's Certificate will be issued for the foal, conceived by this mating, when stallion fee and all other expenses have been paid in full
10. The following stipulations will be adhered to when contracting for shipped semen:

Transported Cooled Semen

- ◆ Mare owner or their agent must contact TL Quarter Horses at 740-439-0111 or 740-260-4239, 24 hours prior to needing semen. Shipping fee will be required before shipment is made, including a **\$175.00** chute fee for each collection.
- ◆ Full payment of stallion's stud fee, full payment of semen shipping & collection fees (if applicable), copy of mare's registration papers and signed copy of semen contract must be received by the TL Quarter Horses prior to semen shipment.
